Note signed by the heirs of Joseph and Frances Allen stating  
they will pay for any damage or loss to the administrators  
of the Allen estate, due to the sale of Martin and Caty, the  
dower Negroes. Also will pay for damage which may accrue  
from the heirs of Wright Allen. Signed by: William W.  
Allen, James R. Boardman, Margaret Landen, and David Allen.
