- 1 : Receipt, for six barrels of salt (salt bill# 20), sold by W. Noble and Thomas Hunter, purchased by J. A. Piatt. Cincinnati, Nov. 18, 1815
- 2 : Receipt, for store goods, sold by J. A. Piatt, purchased by Wait Vaughan, arrived in Pittsburgh Oct. 14, 1815, payment sent to Cincinnati, Nov. 13, 1815
- 3 : Receipt, for store goods, sold by J. A. Piatt, Philadelphia, Sept. 22, 1815, purchased and received by William Bouham of Pittsburgh, Oct. 14, 1815
- 4 : Receipt, for store goods, J. A. Piatt, C. Cook of Brookville, Nov. 22, 1815
- 5 : Receipt, for store goods, sold by John Gaddis, purchased by J. A. Piatt at Brookville, Nov. 21, 1815
- 6 : Receipt, for store goods, sold by J. A. Piatt, purchased by Carter Hirondon, Cincinnati, Dec. 15, 1815
- 7 : Receipt, for store goods, purchased by Charles G. McMurry, Cincinnati, Apr. 3, 1915
- 8 : Receipt, for store goods, purchased by (illegible signature), sold by J. A. Piatt, Brookville, Apr. 10, 1820
- 9 : Bill, for merchandise purchased by J. A. Piatt, sender James Brownle, July 3, 1823
- 10 : Receipt, for paid bill, paid by McKemy (J. A. crossed out) Piatt, payment received by Conrad Puerturf, June 10, 1824
- 11 : Loan Agreement between J. A. Piatt and G. Wily, Apr. 16, 1825
- 12 : Receipt, for taxes paid by heirs of J. A. Piatt, 1829
- 13 : Receipt, payment delivered by Abraham Hainline, Sr., for J. A. Piatt's county taxes, received by John W. Nennermy, 1834
