#### **Notes from the latest CAP Meeting**

Meredith Moore, Sustainability Programs Coordinator, spoke on campus-wide sustainability efforts through the Illinois Climate Action Plan (iCAP). For more information see the [iCAP website](#) and campus [map of improvements](#).

Important updates regarding staff pay and benefits:

- The University elected not to defer federal taxes for withholding as taxes are still due to be paid on schedule.
- Self-managed plan is now called the Retirement Savings Plan. The plan is migrating to Voya and now includes a hybrid pension/401K plan.
- Some APs are losing a number of vacation days due to COVID. CAP appealed the 5-day roll over limit and requested that more roll-over days be given. The concern was heard but not acted on.

Jake Metz will join CAP as our second representative from District 9.

The upcoming meeting on November 5<sup>th</sup> will feature Chancellor Robert Jones – please consider attending!

## L-CAP Committee Report

### **Highlights from August 31 and September 21 L-CAP meetings:**

- New members were welcomed August 31, and John Laskowski and Jake MacGregor agreed to co-chair the committee for 2020-2021.
- In September we agreed that an AP orientation on the role of Library Committee of Academic Professionals and the campus Council of Academic Professionals would help us engage with APs, in particular in the context of representing AP interests when L-CAP chairs attend EC meetings.

### **Highlights from September 14 meeting with Dean Wilkin:**

- Campus has approved the Library's AP Promotion Process, which is now officially out of pilot/beta mode. Future cycles will include a campus level review and primary banner title and job description updates for promoted APs. Dean Wilkin expressed a commitment to funding the program every year.
- Regarding L-CAP participation in EC meetings, Dean Wilkin recommended reviewing [past and upcoming EC agendas](#) to identify topics L-CAP may want to address.
