Jan. 23, 1959, Advertisement in the *Press and Enterprise*, written by F.E. (Francis) Pinkerton in an attempt to defend himself against censorship charges in connection with his position as library trustee

Apr. 6, 1961, Letter from Painter and Painter, Attorneys-at-Law, Houston, to Ralph Kirby, Houston, in regard to life insurance coverage of Bert and Jean Pinkerton

Aug. 9, 1969, Genealogical notes regarding John M. and Nancy Gay Cox and children, copied in 1969 by Emmett Kirby. Information found in Pinkerton family album, apparently collected by Bert Pinkerton or Ralph Kirby
