Appendix: Permission Form to Nominate Material Held at Other Institution

If the nominating individual or institution wishes to nominate a title held in an institution other than their own, they must receive written permission from the institution who owns the films. A permission form must be signed by both the nominator and the holding institution and uploaded in this section.

Disclaimer: The institution must understand that if a newspaper held in their collection is selected, it will be their responsibility to ship the reel(s) to the University of Illinois Urbana-Champaign. Illinois Newspaper Staff will assess the reels and prepare them for digitization. Reels will then be sent to a vendor for digitization. The holding institution must understand that, if selected, their material will be out of their collection for up to four months. An additional copy of the microfilm will be created and placed in the Library of Congress for preservation and the microfilm reels will be shipped back to the holding institution by Illinois Newspaper Project staff.

We understand that, if selected, microfilm from our collection will be temporarily removed from our institution for up to four months. We also understand that the Illinois Newspaper Project (administered by the University of Illinois Urbana-Champaign) is not responsible for lost or damaged collection material.
